



How To Sign a Candidate’s E-Qual Petition

Voters should use this guide to sign candidate petitions via E-Qual. Please follow the steps below and email candidate@azsos.gov for additional assistance.

Step 1 – Visit: <https://apps.azsos.gov/equal/> and click, “Sign A Candidate Nominating Petition”.



Step 2 – Enter your information exactly as it appears on your Driver’s License.

Voter Authentication

The voter authentication screen requires personal information. This information is used to access your voter registration record and is not used for any other purpose. The personal information you provide will not be shared with any candidate or any candidate committee, except if you decide to sign a nominating petition or \$5 Qualifying Contribution Form. In which case, the same information you would provide on a paper nominating petition or \$5 Qualifying Contribution Form will be available to the candidate.

Note: If you receive an error message after clicking “Submit”, we recommend trying the following:

1. Confirm there are no typos.
2. Try using a different ID to log in: Driver’s License Number or Voter Registration Number and last 4 of Social Security Number.

Step 3 – Confirm Your Address is Correct

- ✓ Click YES, if the partial street address and zip code are correct
- ✓ Click NO, if the partial street address is outdated or incorrect
- If the information is incorrect, update your voter registration on servicearizona.com

Step 4 – Click on the Candidate whose Petition You Want to Sign

- E-Qual will only show you petitions for which you are an eligible signer. (i.e. candidates in the same political party, candidates with no political party, and candidates in the district in which you live)
- In early March 2022, E-Qual will be temporarily taken offline for congressional and legislative candidates so the counties can implement the new 2022 maps from the Independent Redistricting Commission. You will still be able to sign petitions for candidates running for U.S. Senator and Statewide offices.

Test Example

PARTISAN NOMINATION PETITION

I, the undersigned, a qualified elector of the county of Maricopa, the state of Arizona, and of the State of Arizona and a member of the Libertarian party or a person who is registered as no party preference or independent as the party preference and is registered with a political party that is not qualified for representation on the ballot, hereby nominate Test Example who resides at [REDACTED] in the county of Maricopa for the party nomination for the office of Corporation Commissioner to be voted at the primary election to be held August 2nd, 2022 as representing the principles of such party, and I hereby declare that I am qualified to vote for this office and that I have not signed, and will not sign, any nomination petition for more persons than the number of candidates necessary to fill such office at the next ensuing election.
