On January 16, 2024, a federal court issued an order prohibiting this Office from accepting any candidate filings or from listing a No Labels Party candidate on the 2024 Primary or General Election ballots except for electors for President and Vice President, if the No Labels Party chooses to nominate candidates for those offices.
